This AMENDMENT NO. 1 TO SUBGRANT AGREEMENT, NO. 2019-2020-WIOA-ONE-STOP-OPERATOR-11477 which was entered into the 18th day of October, 2019, by and between CareerSource Broward, (hereinafter referred to as CSBD) the administrative agency and fiscal agent for the CSBD Council of Elected Officials, (hereinafter referred to as Council) a consortium of the Cities of Fort Lauderdale and Hollywood, and Broward County, existing under and by virtue of the laws of the State of Florida as an Inter-local Unit of Governments, and the Broward Workforce Development Board, Inc., (hereinafter referred to as the BWDB) a not for profit corporation having its principal offices at 2890 Cypress Creek Road, Fort Lauderdale, FL 33309 AND WORKFORCE GUIDANCE ASSOCIATES, LLC, (hereinafter referred to as Sub-grantee, existing under and by virtue of the laws of the State of Florida as a for profit limited liability corporation having its principal office at 10456 NW 48<sup>th</sup> Manor, Coral Springs, FL 33076. to begin on the date this Agreement is signed by all the parties and to terminate on **September 30, 2021**.

WITNESSETH THAT

WHEREAS, CSBD has entered into an agreement with the Governor of the State of Florida for the implementation of workforce development programs and activities in accordance with the Workforce Innovation and Opportunity Act of 2014, P.L. 113-128 (WIOA); AND

WHEREAS, in accordance with WIOA CSBD has competitively selected Sub-grantee to serve as the one-stop operator for the local workforce development area to coordinate programs among the one-stop partners identified in WIOA; AND

WHEREAS, CareerSource Broward and Sub-grantee entered into an Agreement effective October 18, 2019, to serve as the one-stop operator for the local workforce development area to coordinate programs among the one-stop partners identified in WIOA; which expires on September 30, 2020; AND

WHEREAS, at their meeting on May 28, 2020, the CSBD governing boards approved the renewal of the Agreement for an additional one (1) year term;

NOW THEREFORE, in consideration of the mutual terms, conditions, promises, covenants, and obligations hereinafter set forth, and subject to the terms and conditions hereinafter stated, the parties hereto agree to amend Sub-grantee Agreement NO. 2019-2020-WIOA-ONE-STOP-OPERATOR-11477 CSBD and Sub-grantee agree as follows:

1. Article II, Scope of Work, is amended to substitute the year 2021 for 2020 and PY 20 for PY 19 as follows:

201.21

- d. Sub-grant Recipient shall prepare a draft report for review and approval by the CSBD Operations Department by February 2021:

- i. Listing three areas identified for coordination.
- ii. The individuals and their titles who met with Sub-grant Recipient and provided input to the recommendations being developed.
- iii. The benefit to be realized by each of the listed partners.
- iv. A process map/Visio depiction for the action steps needed for each service activity listed such that CSBD and the partner can work toward implementation of the coordination initiative.

201.24 Sub-grant Recipient shall develop a matrix to be shared with the one-stop partners so that they may better understand each other's programs. The matrix shall minimally provide the following information:

- d. Performance requirements including state set performance baselines for PY 20

2. Article III, Compensation, is amended to substitute \$56,000.00 for \$45, 000.00

300.1 Sub-grant Recipient shall be paid four thousand six hundred and sixty-six dollars and sixty-six cents (\$4666.66) a month for a total of (\$56,000.00) for the tasks outlined in Section 201 for the period of October 1, 2020 through September 30, 2021.

3. All provisions of said Agreement, which are not in conflict with this Amendment, shall continue to be enforced in accordance with the terms and conditions therein.
4. This Amendment and all its attachments are made a part of said Agreement.
5. The effective date of this amendment shall be the date on which it has been signed by all the parties.



