This is Amendment Number Four to the Audit Contract entered into the 5th day of October, 2018 by and between, CAREERSOURCE BROWARD, (CSBD), the administrative entity for the Broward Workforce Development Board (BWBD), Inc., a not-for-profit corporation organized under the laws of the State of Florida and for the CareerSource Broward Council of Elected Officials and ANTHONYBRUNSON P.A., hereinafter referred to as "Contractor."

WITNESSETH THAT:

WHEREAS, CSBD has entered into a Contract with the Governor of the State of Florida for grants for the execution and implementation of workforce programs; AND

WHEREAS, CSBD has entered into a Contract with Contractor to provide for an organization-wide audit of its funds in accordance with the Office of Management and Budget's (OMB) Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards (hereinafter referred to as the "Uniform Guidance"); AND

WHEREAS, the Contract is scheduled to expire on September 30, 2022;
AND

WHEREAS, an extension of the Contract through September 30 2023 was approved by the Broward Workforce Development Board and the CareerSource Broward Council of Elected Officials at their August 25, 2022 and August 31, 2022 respective meetings;

NOW THEREFORE, in consideration of the premises and the mutual Covenants and obligations herein contained, and subject to the terms and conditions hereinafter stated, the parties hereto agree to amend Contractor's Audit Contract as follows:

1. References in the Contract to the year 2021 shall now be amended to read 2022. Paragraphs may be renumbered where no other change is made to the language without any special demarcation.
2. Article 3, Term, 3.1, shall be amended to read:

This Agreement shall commence on the date that this instrument is fully executed by both parties. **The term to be encompassed by this audit shall begin with the audit of the fiscal year, which began on October 1, 2021 and which ends on September 30, 2022.** The term of this Amendment shall begin on October 1, 2022 and shall end on September 30, 2023. This is the fourth renewal under the Agreement No. 2018-2019-VENDOR-12002.

3. Article 6, Compensation, 6.1, Maximum Fee, is amended to delete the stricken language and to include the underscored language as follows:

Contractor shall be paid Thirty-three Thousand Dollars (\$33,000.00) **for the audit covering the period October 1, 2020 and ending September 30, 2021 October 1, 2021 and ending September 30, 2022.**

4. All provisions of the Contract entered into on October 5, 2018, which are not In conflict with this Amendment, shall continue to be enforced in accordance with the terms and conditions therein.
5. This Amendment and all its attachments are made a part of said Contract. The effective date of this Amendment shall be the date on which it has been signed by all parties.
